Making a Difference

Below are a few examples of the differences we make to our clients year in and year out:

- When a not-for-profit client was audited by the IRS (a 2 yr process), we coordinated the response, disputed and appealed findings, and argued successfully over such gray areas as a not-for-profit providing a no-cost residence to the Executive Director, Unrelated Business Income Tax assessment against weddings and corporate events on the premises, and 1099 process shortcomings, saving the client over \$150,000 in taxes, interest and penalties.
- We are in the process of executing a 10 yr plan to convert two not-for-profit entities from taxable private foundations to a publicly supported charity and supporting organization which will save the client \$10,000 to \$20,000 annually when completed.
- With the advent of the Tax Cuts & Jobs Act of 2017, we correctly forecast its implications, in particular for the new employee parking tax. For a number of clients, we assisted in developing a strategy for minimizing or eliminating any liability.
